ORDINANCE NO. 37

AN ORDINANCE AUTHORIZING THE FILING OF
A COMPLAINT FOR APPROPRIATION OF REAL
ESTATE LOCATED IN LEBANON, INDIANA

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana
two-thirds of its members being present and concurring therein:

SEC. 1. That the City of Lebanon, Indiana, take the necessary legal action to
file a Complaint for Appropriation of Real Estate located in Lebanon, Indiana,
against Milford Campbell, Katherine Campbell, Dorine Horning, and Robert Horning, of
the following described real estate, to-wit:

A strip of land 10 feet in width along the entire East
side of the aforesaid tract, such 10 feet being in addition
to the present 20 feet right-of-way, making a total right
of way width of 30 feet, and containing .027 acres, more or
less, and being part of the following described real estate:

A part of Lot No. 11 in Richardson's Sub-Division of Out Lot No. 45 in
Longley's Addition to the Town, now City of Lebanon, Indiana, described
as follows, to-wit: Commencing at a point 16 1/2 feet North and 16 feet
East of the Northeast corner of Lot No. 9 in Richardson's Sub Division
of Out Lot 45 in Longley's Addition and run thence North 102 1/2 Feet
more or less, to a point on the North Line of said Lot No 11, thence
East 66 feet, thence South 23.85 feet, more or less, to Lot No. 10 in
Richardson's Sub-Division thence South 40 degrees West 102.7 feet, more
or less, to the point of beginning, Also Lot No. 10 in Richardson's
Sub-Division of Out Lots 43,44 and 45 in Longley's Addition to Lebanon
Indiana, except 120 feet off of the South end of said lot and also
except 20 feet off of the East Side of said lot. Lot No. 11 in
Richardson's Sub-Division of part of Out Lots 43,44 and 45 in Longley's
Addition to the City of Lebanon, Boone County, Indiana, except commencing
at a point 16 1/2 feet North and 16 feet East of the Northeast corner of Lot
No. 9 in Richardson's Sub-Division of Out Lot 45 in Longley's Addition and
run thence North 102 1/2 feet, more or less, to a point on the North
line of said Lot No. 11, thence East 66 feet, thence South 23.85 feet, more
or less, to Lot No. 10 in Richardson's Sub-Division, thence South 40
degrees West 102.7 feet, more or less to the point of beginning and also
except a strip of ground 8 feet wide off of the entire West side of
said Lot No. 11.

That said real estate sought to be appropriated shall be used for the
purpose of constructing a bridge across Prairie Creek on North Grant Street
in Lebanon, Indiana.
