ORDINANCE NO # 668 6-68

AN ORDINANCE CREATING THE OFFICE OF CITY JUDGE FOR THE CITY OF LEBANON, INDIANA, PROVIDING FOR THE APPOINTMENT, AND ELECTION AND TERM OF A CITY JUDGE AND THE SALARY AND EXPENSES THEREFOR.

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana,

Section 1. That there is hereby created the office of City Judge for the City of Lebanon, Indiana, effective on the first day of July, 1968, or as soon thereafter as possible, as hereinafter provided.

Section 2. Said City Judge shall be a qualified attorney, admitted to practice law in the State of Indiana.

Section 3. Said City Judge shall establish a minimum of one (1) regularly scheduled session of Court each week and such additional times as may be required.

Section 4. That procedures be instituted for the appointment of such City Judge according to law, said appointment to take effect on July 1, 1968, or as soon thereafter as possible, said appointive term to expire on January 1, 1972, and that said City Judge shall be elected thereafter for a term of four (4) years at the preceding city election to be held in 1971 and the successor judge shall thereafter be elected in accordance with the provisions of the law now or hereafter in effect for a term provided by law.

Section 5. Said judge shall exercise the powers and duties of such office as provided by law now in force in the State of Indiana, and hereafter passed by the General Assembly of the State of Indiana.

Section 6. That it shall be the duty of the proper officers of the City of Lebanon, Indiana to include in the annual budget of said City, each and every year for the following year, and to make special appropriation, if necessary, for the salary of said Judge for the balance of the year 1968, and to determine the amount of salary of City Judge by Ordinance, as by law now provided, and the necessary expenses of the office.
