PETITION FOR ANNEXATION AND DEDICATION AND ACKNOWLEDGEMENT
OF TRACT OF REAL ESTATE FOR CHURCH PURPOSES TO THE CITY OF
LEBANON, INDIANA

The undersigned, the Trustees of the Church of Christ of Lebanon, Boone County, Indiana, on behalf of the said Church of Christ of Lebanon, Boone County, Indiana, do hereby petition the Common Council of the City of Lebanon, Boone County, Indiana, for a special ordinance for the purpose of annexing the property described as follows to-wit: A part of the Northwest quarter of Section 6, Township 18 north, Range 1 east, situated in Center Twonship, Boone County, Indiana, and being more particularly described as follows, to-wit; Begin at the northwest corner of the aforesaid tract and proceed thence south 0 degrees 20 minutes 53 seconds west along the west line of the quarter section for a distance of 508 feet, thence north 89 degrees 58 minutes 54 seconds east for a distance of 200 feet to the point of beginning, from said point of beginning proceed thence south 0 degrees 20 minutes 53 seconds west for a distance of 250 feet, thence north 89 degrees 58 minutes 54 seconds east for a distance of 1140.83 feet to a point in Indianapolis Avenue (formerly the centerline) thence north 34 degrees 33 minutes 0 seconds west for a distance of 303.47 feet, thence south 89 degrees 58 minutes 54 seconds west for a distance of 967.21 feet to the point of beginning, containing 6.0493 acres more or less and being subject to an easement of 53.75 feet of even width on and along the easternmost boundary for Indianapolis Avenue, and also being subject to an easement for the Cannon Court Drain.

that said tract consisting of 6.0493 acres, more or less is owned by the Church of Christ and said tract is to be used for the erection of a Church building to be used as a sanctuary, Church School and possible a Church parsonage, all pursuant to Chart 5 of the Zoning Ordinance of the City of Lebanon, Boone County, Indiana; that said tract will be used as an entire area without any subdividing or subdivision thereof; that the uses to be made of this tract will be for general church purposes only, that the petitioners will attach to and become a part of the Lebanon Utility system, will use Lebanon water from the main located on the west side of Business Route No. 52 and will connect with the Lebanon sewer system on the east side of Business Route 52.

The undersigned would further show that the north boundary line of the tract as heretofore described is contiguous with the south boundary line of Jackson Highway Addition.
