

SECTION 2. Said real estate above described in owned by Adler & Lenox, Inc. a corporation organized and existing under the laws of the State of Indiana, and the use of said real estate is to be limited to the construction of a single family dwelling pursuant to Chart 1 of the Zoning Ordinance of the City of Lebanon, Boone County, Indiana. It is further provided that all covenants apply to Edgewood Addition, Section 1, which is contiguous and adjacent to the real estate described above, shall apply to the real estate herein annexed to be covenants running with the land as so provided in Edgewood Addition.

SECTION 3. This Ordinance shall become effective from and after its passage and publication according to law.

ORDINANCE NO. 3-69

ORDINANCE FIXING THE SALARIES  
OF CERTAIN EMPLOYEES OF THE  
CITY OF LEBANON, INDIANA  
BEGINNING JANUARY 1, 1970

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, two-thirds of its member being present and concurring therein;

SECTION 1: That the salaries of the following employees of the City of Lebanon, Indiana, beginning January 1, 1970 be as follows:

A. STREET DEPARTMENT

Salary of Commissioner----- 124.50 Wkly.  
Salary of Laborers ----- 99.24 "

B. GARBAGE DEPARTMENT

Salary of Driver----- 99.24 Wkly.  
Salary of Assistants----- 99.24 "  
Salary of Bulldozer Operator----- 84.00 "

The above weekly rates to apply for a 40 hour week. However, when extreme emergencies arise requiring the above names employees to work more than 40 hours per week as intended, they shall be compensated at the following rates; Street Commissioner, \$3.11 per hour; Laborers, \$2.48 per hour and to be allowed only during extremes occasioned by weather or other unusual conditions; such times to be at the discretion of the Mayor or the City Clerk-Treasurer of the City of Lebanon, Indiana.

C. PARK DEPARTMENT

Salary of Superintendent----- 118.20 Wkly.  
Salary of Assitant ----- 105.54 "  
Salary of Laborer ----- 99.24 "  
Salary of Extra Help ----- 72.24 "

Overtime shall be allowed only during extreme emergencies occasioned by the weather or other unusual conditions: such times to be at the discretion of the Mayor or Clerk-Treasurer.

D. POLICE DEPARTMENT

Salary of Chief ----- 552.60 Mon.  
Salary of Night Sgts. ----- 515.94 "  
Salary of First Class Patrolman ----- 487.60 "  
Salary of Second Class Patrolman ----- 474.60 "  
Salary of Third Class Patrolman ----- 461.58 "  
Salary of Desk Man ----- 325.06 "
