

SECTION 8: It shall be unlawful for any person to engage in the business of either plumbing, heating and ventilating or electrical wiring in the City of Lebanon, Indiana, without first having procured such license required for their particular business and having given such bond and proof of liability insurance as provided in Section 1 hereof and each days violation hereof shall constitute a separate offense.

SECTION 9: Any person violating the provisions of this Ordinance shall on conviction be fined in any sum not exceeding \$100.00 to which may be added imprisonment in the County Jail for any period not exceeding thirty (30) days.

SECTION 10: An ordinance regulating the business of plumbing and providing for the licensing of plumbers and penalties for the violation thereof, passed by the Common Council April 13, 1953 is hereby repealed.

SECTION 11: An ordinance regulating the business of electrical wiring and providing for the licensing of electricians, the issuance of permits for electrical wiring and penalties for the violation thereof, passed by the Common Council May 11, 1936 is hereby repealed.

SECTION 12: This ordinance shall be in full force and effect from and after its passage and publication according to law.

ORDINANCE NO. 6-69

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY INTO THE CITY OF LEBANON, INDIANA, 1969.

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, two-thirds of its members being present and concurring therein, that,

SECTION 1. The territory described in this section is hereby annexed into the City of Lebanon, Indiana, upon the terms and conditions contained herein. Said territory, consisting of 0.549 acres, MORE OR LESS, is located in Center Township and more particularly described as follows:

A part of the northwest quarter of Section 31, Township 19 North, Range 1 East of Second Principal Meridian in Boone County, Indiana, more particularly described as follows:

Beginning at a point in the existing Lebanon Corporation line of the City of Lebanon, Indiana, said point being the southeast corner of Lot 70 in Edgewood Addition, Section 1, as per plat thereof in the Office of the Recorder of Boone County, Indiana, in Plat Book 3, page 129, run thence westwardly along the south line of said Lot 70 and said line projected and the existing corporation line aforesaid 120.00 feet; thence south 16°42' west along said corporation line, 52.20 feet to the northeast corner of Lot 71 in Edgewood Addition, Section 1 aforesaid; thence south along the eastwardly line of Lot 71, aforesaid and the eastwardly line projected to the center line of East Washington Street in the City of Lebanon, Indiana, 210.50 feet; thence eastwardly along the aforesaid center line and the corporation line of the City of Lebanon 135.00 feet; thence north 260.50 feet to the place of beginning, containing 0.549 acres, more or less.
