ORDINANCE NO. 5-70

Entitled: Ordinance annexing certain contiguous territory into the City of Lebanon, Indiana, 1970.

BE IT ORDAINED by the Mayor and Councilman of the City of Lebanon, Indiana:

SECTION 1. The territory described in this Section 1 is hereby annexed into the City of Lebanon, Indiana upon the terms and conditions contained herein, said territory consisting of ten acres, located in Center Township, Boone County, Indiana, and more particularly described, to-wit:

A part of the northeast quarter of Section 25, Township 19 North, Range 1 west in Boone County, Indiana, more particularly described as follows, From the northwest corner of the northeast quarter, aforesaid measure eastwardly along and with the north line thereof 866.20 feet; thence southwardly, deflecting right 79°25' a distance of 1062.39 feet to the place of beginning of the within described tract, said place of beginning being in the center line of a proposed street,

Continue thence on the last above described course 224.88 feet to a point in the center line of the Small-Reynolds Ditch as now relocated, thence southwestwardly at right angles to the last above described line and along the center line of said ditch 7.29 feet; thence southwestwardly along the center line of said ditch and deflecting left 40°00' a distance of 111.30 feet, thence southwardly along the center line of said ditch and the southeastwardly line of the property presently owned by the Methodist Hospital and deflecting left 27°39' a distance of 228.77 feet; thence southwestwardly deflecting right 44°15' a distance of 284.05 feet thence southwardly, deflecting left 56°16½ a distance of 10.20 feet to a point which is in the center line of Small-Reynolds Ditch, said point being also the northeast corner of Northfield Village, Section 6, thence southwestwardly, deflecting right 74°51'30" along and with the center line of said Small-Reynolds Ditch and the northerly line of Northfield Village Section 6 a distance of 319.43 thence westwardly deflecting right 18°24' along the aforesaid center line of Small-Reynolds Ditch and the northerly line of Northfield Village Section 6, 25.57 feet; thence northwestwardly deflecting right 86°24'30" a distance of 779.98 feet to a point of the center line of the aforesaid proposed street if projected westwardly; thence northeastwardly at right angles to the last above described course and along the aforesaid street projection 699.83 feet to the place of beginning, containing 10.00 acres, more or less.

Subject to all easement and right-of-ways of record pertaining to said property and subject to a 30.00 foot strip along the entire northerly line thereof for the purpose of a future street dedication.
