

ORDINANCE NO. 8-70

ORDINANCE FIXING THE SALARIES  
OF CERTAIN EMPLOYEES OF THE  
CITY OF LEBANON, INDIANA  
BEGINNING JANURARY, 1971

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA,  
two-thirds of its members being present and concurring therein;

SECTION 1: That the salaries of the following employees of the  
City of Lebanon, Indiana, beginning January 1, 1971, be as follows:

A. 1. STREET DEPARTMENT

Salary of Commissioner-----\$ 130.72 Wkly.  
Salary of Laborers----- 104.20 Wkly.

2. SEWER DEPARTMENT

Salary of Laborers-----\$ 104.20 Wkely.

B. GARBAGE DEPARTMENT

Salary of Laborers-----\$ 104.20 Wkly.  
Salary of Bulldozer operator----- 88.20 Wkly.

The above weekly rates to apply for a 40 hour week. However, when extreme emergencies arise requiring the above named employees to work more than 40 hours per week as inteded, they shall be compensated only during extreme occasions by weather or other unusual conditions; such times to be at the discretion of the Mayor or the City Clerk-Treasurer of the City of Lebanon, Indiana.
