The people whose names appear below, are tax payers and voters in the City of Lebanon, Indiana. They live in homes that border on the first alley north of W. Dicks St. This Alley begins at south West St. and runs west and parallel with W. Dicks Street along the south edge of the Elm Street Trailer Court, thence south, and joins West Dicks Street on the west side of 510 W. Dicks St.

This is a dirt alley, and we believe carries more traffic than any black top alley in this City, The Dust pollutes the homes and the rocks are a safety hazard. This alley carries all of the traffic going to and from the seventy-nine trailers in the trailer court. The traffic travels in and out of this alley by way of the South West Street, West Dicks Street, West Elm St. South Clark St. and South Jamison Street.

All of the streets on all sides of the trailer court and through the trailer court are black-topped except this one alley.

We are appealing to the government of our fair City, in the best way that we know how, in order that we might get this alley blacktopped as soon as possible.

It is equivalent to or worse than a graveled rural road, but yet it is near the center of the city.
