

BE IT FURTHER DECLARED that said annexation and established uses shall be subject to the following conditions:

1. The petitioner will install its own water, sewage and electrical systems in accordance with existing Indiana State Board of Health Code and any requirement of the Lebanon Utilities.

2. That a strip of land 800 feet by parallel lines off of and across the entire west side of said tract and containing approximately 19.32 acres, more or less, be accepted and annexed for the specific use of apartment and/or multi-family dwellings pursuant to Chart 4 of the Zoning Ordinance of the City of Lebanon, Boone County, Indiana.

3. That the remainder of the real estate herein annexed (63.1967 acres, more or less) is hereby annexed for the specific use of light industrial pursuant to Chart 8 of the Zoning Ordinance of the City of Lebanon, Boone County, Indiana, but that any lesser use shall apply to any area where improvements are to be constructed which carry a lesser use than light industrial pursuant to Chart 8 of the Zoning Ordinance of the City of Lebanon, Boone County, Indiana.

4. All plans for the construction of any buildings shall be approved by the City Plan Commission of Lebanon, Indiana, before any construction and/or development begins.

5. No public or private trailer camp, nor any house trailer or mobile home for human habitation shall be permitted on either or both tracts herein described.

6. Any or all streets to be accepted for maintenance by the City of Lebanon, Indiana, for general public use are to be constructed according to specifications of the City of Lebanon, Indiana, Street Department.
