

SECTION III The powers, duties and jurisdiction of said Plan Commission shall be those granted by Statute and all ordinances passed in accordance therewith.

SECTION IV The terms of office of the members of said Plan Commission shall be for a period of four uears, provided, howeved, that the members of the Plan Commission now holding office shall continue in office until the expiration of their respective terms. As each term expires appointments to fill the vacancy shall be made for a period of four years.

SECTION V The officers of said Plan Commission shall be President, Vice-President and Secretary all of whom shall be elected annually by and from among the members thereof; provided however, the present officers shall continue in office for thier respective terms.

SECTION VI Such Plan Commission shall have the powers to adopt rules and regulations for the conduct of its business; provided, however, all rules and regulations now in effect shall continue on effect until modified or changed by action of said commission.

SECTION III This ordinance shall be in full force and effect from and after its passage.
