

WHEREAS, it may be necessary that officers of City of Lebanon be authorized to sign any pleading, document or such instrument as may be required to be signed by City of Lebanon to carry out such action as may be appropriate in the circumstances; and now therefore,


BE IT RESOLVED BY THE COMMON COUNCIL OF CITY OF LEBANON:

SECTION I. That it is in the Best interest of the citizens of City of Lebanon, Indiana, that appropriate action be taken to oppose the collection of sales tax on purchases by its electric utility, which is owned and operated by City of Lebanon, Indiana, and that appropriate action be taken to seek a refund of all sales tax that may have been paid to the State of Indiana by reason of purchases already consummated by said utility.

SECTION 2. That the City hereby retains the services of Paul Hirsch of Haymaker, Hirsch & Fink, Attorneys, of Indianapolis, Indiana, to take appropriate legal action on behalf of City of Lebanon, Indiana, in the cause of action already undertaken by the City of Alexandria, plaintiff, versus, Indiana Department of State Revenue, State of Indiana, defendant, in the Madison Circuit Court, Cause No. C-74-296, to oppose the collection of sales tax on purchases by said electric utility and to take such action as is consistent therewith; the said attorney is hereby authorized to retain and cooperate with such other attorneys as may be hired by other municipalities and carry out the purposes of this resolution; and further, that said attorney is to be employed at no expense to City of Lebanon it being understood that he will be compensated otherwise; and further, it being further understood that said attorney may be retained by other municipalities with respect to carrying out the purposes set forth in this resolution.

SECTION 3. That Wendell B. Iddings, Attorney at Law, is hereby authorized to execute any and all documents and pleadings necessary to carry out the purposes of this resolution.


RESOLUTION FOR TRANSFER
