ORDINANCE NO. 74-19

ORDINANCE ORDERING
CONSTRUCTION OF SANITARY SEWER

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION I: The preliminary resolution of the Board of Public Works and Safety of the City of Lebanon, Indiana, for the construction of the following described sanitary sewer, to-wit:

"Beginning at the northern most end of the existing 8-inch sewer east of Ulen Drive remove the existing lamphole and replace with a manhole, parallel to Ulen Drive and approximately 10 feet northeast
