on the 28th day of October, 1974, be and the same is hereby confirmed.

SECTION 2: The remonstrance to said construction by Mrs. Mary Tyre, James R. Tyre and Janet Tyre be and the same is hereby overruled.

SECTION 3: The Board of Public Works and Safety is hereby ordered to proceed with said construction at the earliest possible time.

ORDINANCE NO. 74-20

AN ORDINANCE PROHIBITING PARKING ON THE SOUTH SIDE OF EAST BUSBY STREET FROM NORTH EAST STREET TO PARK STREET AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:


SECTION 1: Parking is hereby prohibited on the south side of East Busby Street from North East Street to Park Street.

SECTION 2: Motor vehicles found parked in violation of this ordinance may be towed away with the owner thereof being responsible for the tow charge.

SECTION 3: Any person violating the terms hereof, shall on conviction, be fined in a sum of not less than \$1.00 nor more than \$25.00.

SECTION 4: This ordinance shall be in full force and effect from and after its passage and publication according to law.

ORDINANCE NO. 74-21

ORDINANCE ESTABLISHING COUNCILMANIC DISTRICTS FOR THE CITY OF LEBANON, INDIANA

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION 1: The City of Lebanon, Indiana, be and it hereby is divided into four councilmanic districts.

SECTION 2: Said districts shall be numbered one through four and the perimeter descriptions of the boundaries of said districts shall be as follows:

(A) COUNCILMANIC DISTRICT NO. I

Beginning at the intersection of the centerlines of Meridian Street and Main Street and run north with the centerline of Meridian Street to its intersection with the centerline of Washington Street; run west with the centerline of Washington Street to its intersection with the centerline of North Lebanon Street to its intersection with the centerline of West Fordice Street; run east with the centerline of Fordice Street to its intersection with the east boundary line of the City of Lebanon; run south with said boundary line to its intersection with the centerline of East Green Street extended east; run west with the centerline of East Green Street to its intersection with the centerline of South East Street; run north with the centerline of South East Street to its intersection with the centerline of East Main Street; run west with the centerline of East Main Street to the point of beginning.

(B) COUNCILMANIC DISTRICT NO. II

Beginning at the intersection of Main Street and Meridian Street and run north with the centerline of Meridian Street to its intersection with the centerline of Washington Street; run west with the centerline of Washington Street to its intersection with the centerline of North Blair Street; run south with the centerline of West Main Street, run west with the centerline of West Main Street extended to its intersection with the centerline of
