RESOLUTION NAMING STREET AND  
ESTABLISHING ONE-WAY TRAFFIC

SECTION 1; The road running north and west through Miller's Woods from Fordice Road to North Grant Street be and the same given the name of Millerwood Drive.

SECTION 2. The direction of traffic on Millerwood Drive shall be north and west from Fordice Road to North Grant Street.

SECTION 3. The City will not accept Millerwood Drive for maintenance and upkeep until the same is brought up to City Street Standards.

SECTION 4. This resolution shall be in full force and effect from and after its passage.
