RESOLUTION DIRECTING MAYOR  
AND CLERK-TREASURER TO CORRECT ZONE  
MAP TO REFLECT TRUE INTENTION OF PLAN COMMISSION

WHEREAS, the City Council, on recommendation of the Lebanon City Plan Commission, adopted a new and updated Master Plan on September 9, 1974, and;

WHEREAS, during all the public hearings held in connection with the adoption of said Master Plan it was the intention of the Plan Commission to continue the zoning of the real estate at 732 East Fordice Street, Lebanon, Indiana, being the northwest corner of the Grant and Fordice Street intersection, remain as general business, and;

WHEREAS, when the Master Plan was adopted, said real estate inadvertently appeared on the zone map as "A" Residential, and;

WHEREAS, the Lebanon City Plan Commission did, on May 19, 1975, adopt a resolution correcting said error which resolution has been filed with the Clerk-Treasurer;

NOW THEREFORE BE IT RESOLVED by the Common Council of the City of Lebanon, Indiana, that:

SECTION 1: The resolution of the Plan Commission of the City of Lebanon, Indiana, adopted on May 19, 1975, be and the same is hereby approved; that further the real estate at 732 East Fordice Street, Lebanon, Indiana, being the northwest corner of the Grant and Fordice Street intersection, be and the same is to retain the zoning classification of general business which it carried before September 9, 1974.

SECTION 2: The Mayor and Clerk-Treasurer be and they are hereby directed to make the necessary notations on the official zone map to reflect the correction of the original error herein.

SECTION 3: This resolution is to remain in full force and effect from and after its passage.
