

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED:
"AN ORDINANCE PROHIBITING THE CONSUMPTION OF ALCOHOLIC BEVERAGES
IN PUBLIC PLACES IN THE CITY OF LEBANON, INDIANA AND
DECLARING THE SAME TO BE A NUISANCE"

PASSED by the Common Council on the 28th day of July, 1975.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION 1: That the above entitled Ordinance be amended by adding thereto a new section to be known as Section 4 which will read as follows:

SECTION 4: PUBLIC PLACE: For the purpose of this Ordinance the term, Public Place, is hereby defined to be any Governmental owned building, within the City of Lebanon, Indiana, and or, the streets, alleys, parks and municipally owned property of the City of Lebanon, Indiana.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and publication according to law.
