AN ORDINANCE TO AMEND SECTION 27-15
(a) OF CHAPTER 27 OF THE CITY CODE
OF LEBANON, INDIANA

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION I: Subject to the hereinafter set out conditions Section 27-15 (a) of the City Code of Lebanon, Indiana, (the same being Section 30-4 (a) of the Master Plan Code of Lebanon, Indiana) be amended by adding a new paragraph thereto which shall read as follows:

The following described real estate, to-wit:

A part of the southwest quarter of the southeast quarter of Section 30, Township 19 North, Range 1 East, situated in the City of Lebanon, Boone County, Indiana; and being more particularly described, as follows, to-wit: Begin at the northwest corner of the aforesaid southwest quarter of the southeast quarter and proceed thence South 89 degrees 46'24" East (the bearing computed from solar observation) along the quarter-quarter section line, 531.34 feet; thence South 0 degrees 04'59" East, 378.69 feet; thence North 0 degrees 14'41" East, along the east line of Edgewood Subdivision, Section 6, 25.00 feet, thence North 89 degrees 45'19" West, also along the north line of Edgewood Subdivision. Section 6, 240.41 feet; thence North 0 degrees 01'46" West, along the quarter section line, 353.52 feet to the point of beginning, containing 4.4818 Acres, more or less; subject to an easement for Grant Street. All dimensions computed from electronic measurements.

Be and it is hereby rezoned to a "C" residence district as set out in Section 27-14 of the City Code of Lebanon, Indiana, (the same being Section 30-3 of the Master Plan Code of Lebanon, Indiana.)

SECTION II: The above set out zoning district classification shall revert to the now existing zoning classification at the expiration of 270 days from the date of the passage of this ordinance if Parkwood Health Care, Inc., a corporation has not begun construction of a health care facility on the above described real estate all as approved by the Lebanon City Plan Commission on December 15, 1975. Upon the completion of construction of such facility the "C" residence classification shall become permanent.

SECTION III: This ordinance shall be in full force and effect from and after its passage.
