ORDINANCE NO. 76-2
AN ORDINANCE TO AMEND SECTION 27-15
(a) OF CHAPTER 27 OF THE CITY CODE
OF LEBANON, INDIANA

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:
SECTION I: That Section 27-15 (a) of the City Code of Lebanon, Indiana (the same being Section 30-4 (a) of the Master Plan of Lebanon, Indiana) be amended by adding a new paragraph thereto, which shall read as follows:

The following described real estate, to-wit:

Lots No. 1 and No. 4 in Block 31 and 20 feet of uniform width off of and across the entire south side of Lot No. 10 between Blocks No. 30 and 31 in Spencer and McLaughlin's Addition to Lebanon, Boone County, Indiana.

Also, Lots numbered 1, 4, 5 and 8 in Block 30 in Spencer and McLaughlin's Addition to Lebanon, Boone County, Indiana,

be and it is hereby rezoned from an "I-1" enclosed industrial district to a "G B" General Business District as set out in Section 27-14 of the City Code of Lebanon, Indiana, (the same being Section 30-3 of the Master Plan of Lebanon, Indiana).

SECTION II: This ordinance shall be in full force and effect from and after its passage.
