AN ORDINANCE ANNEXING CERTAIN
CONTINUOUS TERRITORY TO THE
CITY OF LEBANON, INDIANA

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, that:
SECTION 1: The following described real estate owned by Dr. Robert M. Strawbridge and Dr. Linda Strawbridge now continuous to the City of Lebanon, Indiana, be and the same is hereby annexed to and declared to be a part of the City of Lebanon, Indiana:

A part of Section 19, Township 19 North, Range 1 East described as follows, to-wit:

Commencing at the southeast corner of the southwest quarter of the southeast quarter of Section 19, Township 19 North, Range 1 East and running thence west with the center line of the Lebanon-Elizaville County Road a distance of 150 feet, thence north 460.6 feet, thence east 150 feet, thence south 460.6 feet to the point of beginning.

SECTION 2: The said above described real estate be, and the same is now zoned as AAA residential.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and publication according to law.

BE IT ORDAINED, by the Common Council of the City of Lebanon, Indiana, that:
SECTION 1: That the real estate, as hereinafter described, to-wit:

A part of the east half of Section 1, Township 18 North, Range 1 West, situated in Center Township, Boone County, Indiana; and being more particularly described, as follows, to-wit:
