RESOLUTION NO. 76-10
RESOLUTION OF CONDEMNATION OR RENOVATION
OF PROPERTY LOCATED AT
112 EAST MAIN STREET, LEBANON, INDIANA

BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA,
THAT:

SECTION 1: The business and apartment property located at 112 East Main Street, Lebanon, Indiana, owned by Indiana University, is delapidated, in need of extensive repairs, and a fire and safety hazard.

SECTION 2: Said property owner has been notified of condition of building by the Administrative Building Inspector, City of Lebanon, Indiana, on October 2, 1975, and again on September 4, 1976.

SECTION 3: Said property is hereby condemned and ordered renovated or removed from the premises, and the property owner is ordered to submit plans for renovation or removal to the Fire Chief and Building Inspector within thirty (30) days after receiving a certified copy of this Resolution.

SECTION 4: The Fire Chief and Building Inspector of the City of Lebanon, Indiana, are hereby ordered to take the necessary steps to carry out the provisions of this Resolution according to Indiana Code 1971-18-5-5, building code and enforcement and City Ordinance 164.

SECTION 5: This Resolution shall take effect from and after its passage.
