ORDINANCE NO. 77-6

AN ORDINANCE TO AMEND AN ORDINANCE ENTITLED, "AN ORDINANCE GRANTING TO LEBANON CATV, INC., ITS SUCCESSORS AND ASSIGNS, THE RIGHT, PRIVILEGE AND PERMIT TO CONSTRUCT AND OPERATE A COMMUNITY ANTENNA AND CLOSED-CIRCUIT ELECTRONIC SYSTEM WITHIN THE CORPORATE LIMITS OF LEBANON, INDIANA, AND ITS ENVIRONS, AND USE AND OCCUPY THE STREETS, ALLEYS, AND OTHER PUBLIC PLACES OF SAID CITY FOR SUCH PURPOSE. PASSED BY THE COMMON COUNCIL ON THE 7TH DAY OF AUGUST, 1967" (Amended by Ordinance No. 74-3, dated February 11, 1974)

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, that:

Section 1. That Section 8 of the above entitled ordinance, repealed and amended February 11, 1974, be and the same is hereby repealed.

Section 2. That in place of said repealed Section, there shall be inserted a new Section 8 which shall read as follows:

SECTION 8: Charges for initial attachment for single outlet shall not be in excess of \$14.90 each and for extensions to initial attachment shall not be in excess of \$6.00. The monthly service charge for single family dwellings shall not be in excess of \$7.00 for the first TV set and shall not be in excess of \$1.50 for each additional set in the subscriber's home.

Section 3. This Ordinance shall be in full force and effect from and after its passage and publication according to law, but not prior to March 1, 1977.

ORDINANCE NO. 77-7
AN ORDINANCE TO AMEND SECTION 27-15
OF THE CITY CODE OF LEBANON, INDIANA
TO CHANGE DISTRICT ZONING FROM "AAA" DISTRICT
TO "UD" DISTRICT

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, that:

SECTION 1: Section 27-15 (a) of the City Code of Lebanon, Indiana (being Section 30-4 (a) of the Master Plan Code) be amended as follows:

(a) The following described real estate, to-wit:

Description attached hereto, made a part hereof and marked "Exhibit A" be deleted from "AAA" zoning district and it shall be rezoned as "UD" (Unit Development Plan) district.

(b) The zone map of the City of Lebanon, Indiana be changed to reflect the change in zoning above set out.

SECTION 2: The future development of said real estate shall be in accordance with the requirements of the Plan Commission of the City of Lebanon, Indiana.

SECTION 3: This ordinance shall be in full force and effect from and after its passage.
