SECTION 2: Section 27-84 (a) of the City Code of Lebanon, Indiana (being Section 30-52 of the Master Plan Code) be amended by adding at the end of such subsection the following clause:

"Provided, however, in the event the developer of a subdivision files a petition for a change in zoning within said subdivision prior to the time he has sold all the lots within said subdivision, he shall give written notice of the hearing on said petition to all of the owners of lots within the subdivision in addition to any other notice required by this code."

SECTION 3: This Ordinance shall be in full force and effect from and after its passage.

ORDINANCE NO. 77-11
AN ORDINANCE ANNEXING CERTAIN CONTIGUOUS
TERRITORY TO THE CITY OF LEBANON, INDIANA

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, that:
Section 1: The following described territory now contiguous to the City of Lebanon, Indiana, be and the same is hereby annexed to and declared to be part of the City of Lebanon, Indiana:

A part of Section 26, Township 19 North, Range 1 West, described as follows, to-wit:

Commencing at the southwest corner of the east one-half (1/2) of the north-east one-fourth (1/4) of the southeast one-fourth (1/4) of Section 26, Township 19 North, Range 1 West and running thence north 497.8 feet, thence east 767 feet, thence south 484.74 feet, thence west to the point of beginning.

Section 2: The above described property shall be annexed and zoned as "A" residential district.

Section 3: This ordinance shall be in full force and effect from and after its passage and publication according to law.

ORDINANCE NO. 77-13
AN ORDINANCE AMENDING CHAPTER 6 OF THE CITY CODE OF
LEBANON, INDIANA BY INCLUDING THEREIN AN ARTICLE TO
