

SECTION 3: A new article shall be inserted in the City Code of Lebanon, Indiana immediately following Article I of Chapter 6 which shall be Article II of Chapter 6. Said article shall consist of five sections number 6-10 through 6-14 which shall read as follows:

Section 6-10: The term "motorized bicycle" when used herein shall mean - A bicycle with operable pedals which may be propelled by human power or by an internal combustion engine or a battery powered motor, or by both, and when powered by an engine having a rating of no more than one and five-tenths (1.5) brake horsepower and a cylinder capacity not exceeding fifty (50) cubic centimeters, an automatic transmission, and a maximum design speed of no more than twenty-five (25) miles per hour on a flat surface.

Section 6-11: It shall be unlawful for any person to operate a motorized bicycle propelled wholly or in part by muscular power upon any of the streets, alleys or public highways of the City, unless the owner thereof has first made application to the police department for a license therefor. That the annual fee for such license shall be \$5.00 which shall be paid in advance before July 1, of each year. The Clerk-Treasurer is hereby authorized to issue; upon receiving the application thereof, a license to expire June 30 in the year following issuance. Such license shall authorize the operation of such motorized bicycle upon the streets, alleys, and public highways of the City of Lebanon, Indiana, provided no such vehicle shall carry anyone other than the operator.

Section 6-12: Any motorized bicycle properly licensed hereunder shall be operated in accordance with all traffic laws of the State of Indiana and traffic ordinances of the City of Lebanon, Indiana.

Section 6-13: Failure of the holder of the license to comply with the terms hereof shall be a violation of this ordinance. It shall be a violation of this ordinance for the holder of the license to knowingly permit a violation of the terms hereof.

Section 6-14: The penalty for the violation of the terms hereof shall be punished in accordance with the provisions of Section 1-10 of the City Code of Lebanon, Indiana.

SECTION 4: This ordinance shall be in full force and effect from and after its passage and publication according to law.
