ORDINANCE NO. 77-16

AN ORDINANCE TO AMEND CHAPTER 14, SECTION 14-3,
OF THE CITY CODE OF LEBANON, INDIANA

BE IT ORDAINED BY THE COMMON COUNCIL OF LEBANON, INDIANA THAT:

SECTION 1: Section 14-3 of the City Code of Lebanon, Indiana be amended by striking therefrom all of subsections 14-3 (a) and (b); that a new subsection 14-3 (a) and (b) shall be substituted therefore which shall read as follows:

SECTION 14-3 License Fees.

- a. Each person, firm partnership, sole proprietorship, or corporation who operates a massage parlor, massage therapy clinic, or bathhouse, or any combination
