

thereof, shall pay an annual license fee of Five Hundred Dollars (\$500.00) for an operator's license. An operator's license shall be valid for a period of twelve (12) months from the date of its issuance and may be renewed for an additional twelve (12) months period upon payment to the Clerk-Treasurer for Five Hundred Dollars (\$500.00) operator's renewal fee provided the same is accompanied by an affidavit setting forth changes, if any, of circumstances or conditions that would affect or alter the information contained in the applicant's application for an operator's license and setting forth whether the applicant is abiding by the terms and provisions of this ordinance.

- b. The Clerk-Treasurer shall charge and collect a semi-annual fee of One Hundred Dollars (\$100.00) for each masseuse and/or massage therapist license; a masseuse and/or massage therapist license shall be valid for a period of six months from the date of its issuance and may be renewed upon the payment to the Clerk-Treasurer of the One Hundred Dollars (\$100.00) license fee provided the same is accompanied by a certificate from a duly license medical practitioner in Boone County, Indiana, on a form prescribed by the Health Department of Boone County, Indiana certifying that said applicant is free from communicable diseases and that said examination has been made within ten days prior to the application for the renewal of said license, or permit.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and publication according to law.
