ORDINANCE NO. 77-21

AN ORDINANCE AMENDING ORDINANCE NO. 76-17 FIXING
THE SCHEDULE OF RATES AND CHARGES TO BE COLLECTED
BY THE CITY OF LEBANON, INDIANA FROM THE CUSTOMERS
SERVED BY THE MUNICIPAL ELECTRIC UTILITY OF SAID
CITY AND OTHER MATTERS CONNECTED THEREWITH

WHEREAS, the City of Lebanon, Indiana owns and operates a Municipal Electric Utility for the purpose of providing and distributing electrical energy in said City and surrounding areas; and

WHEREAS, the Public Service Commission has found the rates and charges for the use of and services rendered by the Municipal Electric Utility of the City of Lebanon, Indiana are too low and insufficient to enable the City to pay increased purchase power costs and properly operate its Municipal Electric Utility, and provide for depreciation thereof; and has further found the proposed rates and charges adopted in Ordinance No. 76-17 are higher than necessary to produce the revenue needed and has directed said rates should be reduced; Now Therefore;

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA:

SECTION 1: That Section 1 of Ordinance No. 76-17 be amended to read as follows:

Section 1: The rates and charges for the services rendered by the Municipal Electric Utility are hereby fixed as follows:

See Exhibit A attached hereto and made a part hereof.

Section 2: All ordinances and parts of ordinance in conflict herewith are hereby repealed; upon the schedule of rates and charges fixed by this ordinance becoming effective.

Section 3: This ordinance shall be in full force and effect from and after its passage and filing with the Engineering Department of the Public Service Commission of Indiana.
