

Range 1 West of the Second Principal Meridian, and being more particularly described as follows to-wit:

From the Southeast corner of said Quarter-Quarter Section run "West 3 chains and 56 links to the center of U. S. Highway No. 52, thence North 41 degrees West with center of said highway 656.80 feet to the place of beginning for this description; thence deflecting left 90 degrees 37 right 92 degrees 30 minutes measure Northwesterly 249.90 feet; thence deflecting right 36 degrees 57 minutes measure Northerly 409.88 feet to a point in the center line of the exit ramp from Interstate Road No. 65 (southbound traffic); thence deflecting right on an 8 degree curve measure 531 feet to the point of intersection of said centerline of the concrete pavement with the West edge of the blacktop pavement on U. S. Highway No. 52; thence deflecting left 5 degrees 40 minutes measure Southeasterly 94.30 feet to the place of beginning, containing 4.514 acres, more or less."

ORDINANCE NO. 77-24

AN ORDINANCE TO AMEND ARTICLE III OF CHAPTER 2 OF THE
CITY CODE OF LEBANON, INDIANA BY INSERTING THEREIN
DIVISION 3 THEREOF WHICH SHALL BE ENTITLED "PERSONNEL
POLICIES"

BE IT ORDAINED BY THE COMMON COUNCIL OF LEBANON, INDIANA THAT:

SECTION 1: Article III of Chapter 2 of the City Code of Lebanon, Indiana be amended by inserting therein, immediately following Section 2-43, Division 3 which shall read as follows:

DIVISION 3 PERSONNEL POLICIES

SECTION 2-44 - Rights and Responsibilities of the City of Lebanon

- It is the desire of the City of Lebanon to establish just and equitable Personnel Policies, for the benefit of it's employees and the citizens of Lebanon. Therefore, the City of Lebanon has instituted these policies, hereafter referred to as the City of Lebanon Personnel Ordinance.
- The City of Lebanon is charged with and continues to maintain, the responsibility and authority to manage and direct, on behalf of the citizens of Lebanon, the operations and activities of the City to the full extent of the law.
- Specific provisions which are found to be unlawful shall be struck from these policies and shall not, as a result automatically void any other provisions contained herein.
- The duties and responsibilities of this City's government shall include, but are not limited to:
