ORDINANCE NO.78-5

AN ORDINANCE APPROVING RULES AND REGULATIONS
FOR THE CURTAILMENT OF ELECTRIC SERVICE REN-
DERED BY THE MUNICIPAL UTILITY OF THE CITY
OF LEBANON, INDIANA TO ITS VARIOUS USERS OF
ELECTRIC POWER.

WHEREAS, an emergency situation exists now with respect to the availability of the electric power for sale by the municipal electric utility of the City of Lebanon, Indiana, and said emergency does exist because of the reduced coal supplies to its sole supplier, Public Service Indiana, as shown by an Order approved by Public Service Commission, Indiana, in Cause No. 35264 approved February 14, 1978, and;

WHEREAS, it would be in the best interest of the municipal electric utility of the City of Lebanon, Indiana, and its customers to adopt emergency rules for the curtailment of electric service due to said emergency, and;

WHEREAS, the Public Service Commission of Indiana, the Indiana Municipal Electric Association and various other utilities in the State of Indiana have undertaken studies as to the most feasible method to implement emergency curtailment rules, and reasonable and proper curtailment rules have been determined, which rules are attached hereto, made a part hereof as Appendix I to this ordinance, and;

WHEREAS, the Lebanon Utility Service Board of the City of Lebanon, Indiana hereby determines that it would be in the best interest of the municipal electric utility of the City of Lebanon, Indiana to approve the curtailment rules contained in Appendix I of said Order insofar as they pertain to electric distribution systems, and to hold a special meeting, suspending all rules in conflict therewith, at which quorum of the members of the Lebanon Utility Service Board are in attendance, for the consideration and approval of this ordinance and recommendation to the Common Council for adoption and are in unanimous agreement with all matters herein set out;

NOW THEREFORE BE IT RESOLVED BY THE LEBANON UTILITY SERVICE BOARD, that:

Section I: That upon receiving notice that the coal supplies of Public Service of Indiana have reached the level set in Appendix I of Public Service Commission Order No. 35264 have reached the critical stage, the Lebanon Utility Service Board hereby adopts the curtailment rules set out in said Appendix I, (a copy of which is attached hereto, made a part hereof, and marked "Exhibit A") for this utility and recommends its approval by the Common Council.
