ORDINANCE #78-8  
AN ORDINANCE TO AMEND SECTION 2-46(b)  
OF THE CITY CODE OF LEBANON, INDIANA

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana THAT:  
Section 1: Section 2-46 (b) (2) of the City Code of Lebanon, Indiana be amended by striking therefrom the words:

"After two (2) years to ten (10) years of continuous service 3 weeks"  
and inserting in place thereof the words:

"After one (1) year through five (5) years of continuous service 2 weeks"  
Section 2: Section 2-46 (b) of the City Code of Lebanon, Indiana be amended by adding Section 2-46 (b) (3) which shall read as follows:

(3) After five (5) years of continuous service beginning with the sixth (6th) year 3 weeks

Section 3: This Ordinance shall be in full force and effect from and after its passage.

ORDINANCE NO. 78-9  
AN ORDINANCE TO AMEND SECTIONS 5-18  
AND 5-19 OF ARTICLE II, CHAPTER 5  
OF THE CITY CODE OF LEBANON, INDIANA,  
BEING THAT ARTICLE RELATING TO CONTROL  
OF DOGS

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, THAT:  
Section 1: Section 5-18 of Article II of Chapter 5 of the City Code of Lebanon, Indiana be amended by striking from Section 5-18 (c) the following words:

"The Mayor shall, in making such appointment, select the person recommended by the operator of the dog pound, should such pound be operated under Section 5-19 (b) (2)."

Section 2: Section 5-19 (b) Article II of Chapter 5 of the City Code of Lebanon, Indiana be amended by striking therefrom Section (2) which reads as follows:

"The City may, by contract to be executed by the Mayor and approved by the Common Council, delegate the operation of the dog pound to the Boone County Humane Society." That said Section be further amended by striking from the second paragraph thereof beginning with the words "provided" on the fourth line the following words:

"Provided, however, that should such pound be operated under paragraph (2) such rules shall be adopted by the operator, after being submitted to the Board of Public Works and Safety for its review, and recommendations to the Common Council." And replacing the; at the end of the word Council with a period (.)

Section 3: This Ordinance shall be in full force and effect from and after its passage.

AN ORDINANCE TO AMEND SECTION 24-66 (b) OF ARTICLE IV  
OF CHAPTER 24 OF THE CITY CODE OF LEBANON, INDIANA RE-  
LATING TO PARKS IN SUBDIVISIONS

Section 1: Section 24-66(b) of Article IV of Chapter 24 of the City Code of Lebanon, Indiana be amended by striking the word "shall" from line No. 5 and inserting in place thereof the word "may". (See Section 31-18(b) of Subdivision Control Ordinance).

Section 2: This ordinance shall be in full force and effect from and after its passage.
