ORDINANCE NO. 78-15
AN ORDINANCE TO AMEND SECTION 2-46(b) OF
THE CITY CODE OF LEBANON, INDIANA

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana THAT:
Section 1: Section 2-46(b) (2) of the City Code of Lebanon, Indiana be amended by striking therefrom the words:

"After two (2) years to ten (10) years of continuous service 3 weeks"
and inserting in place thereof the words:

"After two (2) years through five (5) years of continuous service 2 weeks"

Section 2: Section 2-46(b) of the City Code of Lebanon, Indiana be amended by adding Sections 2-46(b) (3)(b) (4) and (b) (5), which shall read as follows:

(3) After five (5) years of continuous service beginning with the sixth (6th) year 3 weeks

(4) Fifteen years (15) through twenty four (24) years continuous service 4 weeks

(5) After twenty four (24) years continuous service 5 weeks

Section 3: This Ordinance shall be in full force and effect from and after its passage.

VOID ORDINANCE NO. 78-16 VOID
AN ORDINANCE TO AMEND CHAPTER 7 OF THE
CITY CODE OF LEBANON, INDIANA BY ADDING ARTICLE
IA ENTITLED UNSAFE BUILDINGS-PROCEDURES

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana that:
Section 1: Chapter 7 of the City Code of Lebanon, Indiana be amended by adding article IA which shall read as follows:

ARTICLE IA. UNSAFE BUILDINGS-PROCEDURES

Section 7-13: The City of Lebanon, Indiana pursuant to IC 18-5-5.5-1(b) hereby adopts the provisions of IC 18-5-5.5-1 thru IC 18-5-5.5-20 and any amendments thereto as the unsafe building code of the City of Lebanon, Indiana.

Section 7-14: The Fire Chief and Building Inspector shall be charged with enforcement of the provisions of this ordinance.

Section 2: This Ordinance shall be in full force and effect from and after its passage and publication according to law.

ORDINANCE NO. 78-17
AN ORDINANCE PROHIBITING THE PARKING OF MOTOR VEHICLES
OR OTHER VEHICLES FOR A DISTANCE OF SIXTY-FIVE (65) FEET
ON THE WEST SIDE OF INDIANAPOLIS AVENUE FROM SOUTH STREET
INTERSECTION, PROVIDING PENALTIES

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, two-thirds of its members being present and concurring therein:

SECTION 1: It shall be unlawful to park or leave standing any automobile, motor truck, bus or any other vehicle on the west side of Indianapolis Ave. in Lebanon, Indiana, for a distance of sixty-five (65) feet, measured in a straight line from the projection of the north curb line across Indianapolis Avenue intersection in said City at any time.

SECTION 2: Any person violating the provisions hereof shall, upon conviction, be fined in any sum of not less than One Dollar (\$1.00) nor more than One Hundred Dollars (\$100.00).

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and legal publication as required by law.
