ORDINANCE ESTABLISHING SALARIES FOR ELECTED OFFICIALS OF THE CITY OF LEBANON, INDIANA, FOR THE PERIOD FROM JANUARY 1980 TO DECEMBER 31, 1983

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION 1: The salaries of the elected officials of the City of Lebanon, Indiana, for the period from January 1, 1980 to December 31, 1983 shall be as follows:

BEFORE THE COMMON COUNCIL  
OF THE CITY OF LEBANON, INDIANA

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, Section 1. That the zoning of the following described real estate be changed from "AAA" Residence District to "C" Residence District, as defined by the Zoning Code of Lebanon, Indiana. (Ch. 30 "The Municipal Code of Lebanon, Indiana")

A part of the East half of the Southeast quarter Section 25, Township 19 North, Range 1 West of the Second Principal Meridian, described as follows, to-wit:

Commencing 15.15 chains south and 100 feet east of the northwest corner of said half quarter section, and runs thence south 315.48 feet to the center of Camp Street, thence east along the center line of Camp Street 100 feet, thence north 315.48 feet, thence west 100 feet to the place of beginning, located in Center Township, Boone County, Indiana.

Containing .724 acres, more or less.

Commonly known as 510 West Camp Street, Lebanon, Indiana.

A part of the east half of the southeast quarter of section 25, township 19 north, range 1 west of the Second Principal Meridian, and more fully described as follows: Commencing 15.15 chains south of the northwest corner of the east half of the southeast quarter of said section 25, and 200 feet east for a place of beginning, thence south 315.48 feet to the center of Camp Street in the city of Lebanon, Boone County, Indiana, thence east 89.2 feet along the center line of said Camp Street, thence north 315.48 feet, thence west 89.2 feet to the place of beginning, containing 0.646 acres, more or less. Subject to legal highways, rights of way and easements.

Commonly known as 504 West Camp Street, Lebanon, Indiana.

Section 2. That the Building Inspector of the City of Lebanon shall change the Zone Map of the City of Lebanon, Indiana, to show that the above described real estate is zoned "C" Residence District.
