ORDINANCE OF CONDEMNATION OF CERTAIN RESIDENTIAL PROPERTY

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION 1: The residential property located in the City of Lebanon, Indiana, at 616 South East Street, owned by Forest E. McCray, is delapidated, in need of extensive repairs, unfit for human habitation and a fire hazard. The legal description of said residential property is as follows; to-wit:

Lot No. 8 in Rodefer's Subdivision of part of out lots 51 and 52 in Spencer and McLaughlin Addition to the City of Lebanon, Indiana.

SECTION 2: An emergency exists requiring an order of condemnation and immediate removal of the structure on said property from the premises; that said structure is hereby condemned and ordered removed from said premises immediately.

SECTION 3: The fire Chief and the building Inspector of the City of Lebanon, Indiana, are hereby ordered to take the necessary steps to carry out the provisions of this ordinance.
