ORDINANCE NO. 79-22

AN ORDINANCE OF THE CITY OF LEBANON AUTHORIZING THE BORROWING OF FUNDS BY SAID CITY FOR THE PURPOSE OF PROCURING FUNDS TO BE APPLIED ON THE COST OF A PURCHASE OF A SANITARY LANDFILL COMPACTOR.

WHEREAS, the Board of Public Works and Safety has requested the appropriation in the amount of Fifty seven thousand five hundred (\$57,500.00) Dollars to be applied on the cost of the purchase of a sanitary landfill compactor; that said appropriation be made equally divided and made during the calendar year of 1980 and 1981; and

WHEREAS, the Council now finds that it is necessary to provide for the above named project as requested by the Board of Public Works and Safety; that the City has no funds available for such project nor provided for in the budget, making it necessary to authorize the borrowing of monies to procure the required funds; and

WHEREAS, a petition has been filed by the owners of taxable real estate in the City requesting the Common Council to authorize the borrowing of funds for the City for the purpose of procuring funds to be applied on the cost of the purchase of a
