

ORDINANCE NO. 79-25

AN ORDINANCE OF THE CITY OF LEBANON APPROPRIATING THE SUM OF FIFTY-SEVEN THOUSAND FIVE HUNDRED (\$57,500.00) DOLLARS TO BE APPLIED ON THE PURCHASE OF A SANITARY LANDFILL COMPACTOR.

WHEREAS, the Board of public Works and Safety has requested an appropriation in the amount of Fifty Seven thousand five hundred (\$57,500.00) Dollars to be applied on the purchase of a sanitary landfill compactor, and

WHEREAS, the Council now finds that it is necessary to provide for the above named projects as requested by the Board of Public Works and Safety; that the City has no funds available for such projects nor provided for in the budget, making it necessary to authorize the borrowing of money to procure the required funds; and

WHEREAS, a petition has been filed by owners of taxable real estate in the City requesting the Common Council to authorize the borrowing of funds by the City for the purpose of procuring funds to be applied on the purchase of a sanitary landfill compactor which petition the Council finds to be in due form, properly verified by signers thereof, and certified by the Auditor of Boone County as being signed by more than fifty (50) owners of taxable real estate in the City of Lebanon; that said petition in all ways conforms to the requirements of the provisions of IC 6-1.1-20-3; and

WHEREAS, the Council now finds that the City has no funds available or provided for in the budget and tax levy which may be applied on said projects, and that a necessity exists for the making of the additional appropriation hereinafter set out; now therefore,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON:

Section 1. That the sum of Fifty seven thousand five hundred (\$57,500.00) Dollars be and the same is hereby appropriated out of the proceeds of funds heretofore authorized to be borrowed, to be applied on the purchase of a sanitary landfill compactor.

Section 2. This ordinance shall be in full force and effect from and after its passage and signing by the Mayor.
