

Ordinance #80-12 (continued)

to tap the 24 inch water main from the Old Indiana well field as compared to the cost of tapping the smaller water mains, now therefor,

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, BOONE COUNTY, INDIANA:

Section 1: That Section 1 of Ordinance No. 79-1, adopted on January 3, 1979, entitled "An Ordinance to amend Section 1 of Ordinance No. 78-24, an Ordinance establishing rates and charges for the use of and services rendered by the waterworks system of the City of Lebanon, Boone County, Indiana, " be and the same is hereby amended to read as follows: Section 1.

1. There shall be and there is hereby established charges for the tapping of the watermains of the Lebanon Municipal water system as follows:

Each user at the time he is connected with the waterworks system shall pay a charge to cover the costs of: excavating and tapping the main; furnishing and installing service pipe from the main to the lot line; furnishing and installing corporation and stop cocks; and furnishing and installing meter crock (if outside) yoke and meter. The charge for a 5/8 inch meter tap shall be \$160.00 unless said tap is made to the 24 inch water line between the Old Indiana Water Plant and the intersection of Roads 250 North and 100 West, in which case the 5/8 inch meter tap shall be \$225.00. The charge for a 1 inch tap shall be \$275.00 unless such tap is made to the 24 inch water line between the Old Indiana Water Plant and the intersection of roads 250 North and 100 West in which case the 1 inch meter tap shall be \$300.00. The charge for a tap larger than the 1 inch meter tap shall be the cost of labor, materials, power machinery, transportation and overhead incurred for installing the tap, but not less than the charge for a 1 inch meter tap.

Section 2. That all other provisions of Ordinance No. 79-1 shall remain in full force and effect.

Section 3: This Ordinance shall be in full force and effect from and after its passage and signing by the Mayor.
