

Ordinance #80-14 (continued)

SECTION 2: It is the intent of this ordinance to place the responsibility for enforcement of these sections in the office of the Building Inspector of the City of Lebanon, Indiana.

SECTION 3: The words Building Inspector shall be substituted for the words Street Commissioner wherever they appear in Sections 23-19 through Sections 23-31 and Sections 23-40 and 23-41 of the Lebanon City Code.

SECTION 4: The words "Laid in a neat pile along the curb without scattering" appearing in section 23-32 shall be stricken and the words "hauled away and disposed of by the person doing the work" shall be inserted thereon.

SECTION 5: This ordinance shall be in full force and effect after passage according to the laws of the State of Indiana.

ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE CITY OF LEBANON, INDIANA, BEGINNING JANUARY 1981

Section 1: BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, two-thirds of its members being present and concurring therein:
