

ORDINANCE NO. 80-22

AN ORDINANCE TO AMEND SECTION 2-45, DIVISION 3, OF THE CITY CODE OF LEBANON, INDIANA BY INSERTING THEREIN DIVISION 3 THEREOF WHICH SHALL BE ENTITLED "PERSONNEL POLICIES"

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA THAT:

Section 1: Section 2-45, Division 3, Article III of Chapter 2 of the City Code of Lebanon, Indiana be amended by inserting therein, immediately following Section 2-45(c) of Division 3 Section 2-45(d) which shall read as follows:

Sworn policemen and sworn firemen who work on holidays or are called in for duty on off-duty hours between January 31 of one year and January 30 of the following year shall be entitled to compensatory time off. The fire chief and police chief shall schedule such compensatory time off in a manner that will not cause a reduction in protection of the citizens of the City of Lebanon. The hours worked on a holiday between 12:00 midnight and 8:00 a.m. by members of the fire department shall not be eligible for compensatory time off.

Section 2: This ordinance shall be in full force and effect from and after its passage.

ORDINANCE NO. 80-23

AN ORDINANCE TO AMEND CHAPTER 16 OF THE CITY CODE OF LEBANON, INDIANA, BY ADDING ARTICLE IV THERETO TO BE TITLED "SNOWMOBILES-OPERATION WITHIN THE CITY LIMITS".

BE IT ORDAINED BY THE COMMON COUNCIL of the City of Lebanon, Indiana, that:

SECTION 1: That Chapter 16 of the City Code of Lebanon, Indiana, be amended by adding Article IV thereto which shall read as follows:

Article IV. SNOWMOBILES-OPERATION WITHIN THE CITY LIMITS

DIVISION I. GENERALLY

Sec. 16-56, Required of Snowfall.

No snowmobile shall be operated within the corporate limits of the City of Lebanon unless the ground is covered by at least three (3) inches of snow, as determined by the Chief of Police of the City of Lebanon in conjunction with the President or Vice President of the Central Indiana Snow-Eagles organization.

Sec. 16-57, Approved travel route.

(a) Snowmobiles shall be allowed to operate within the corporate limits of the City of Lebanon only upon the public streets set forth in part (b) of this section.

(b) Snowmobiles shall be operated upon the following streets of the City of Lebanon.

Lafayette Ave. north to interstate
Witt Road from Lafayette Ave.
Patterson St. from Chicago St. south to Noble St.
Noble St. from Patterson St. east to St. Rd. 32
West Camp St. from Lafayette Ave. to Garfield St. to Essex to Ulen Dr.
Ulen Dr. from Essex to Elizaville Rd.
Elizaville Rd. to John Bart Rd.
Elm Swamp Rd. from Elizaville Rd. north to city limits
Any part of 250 north in City limits
Grant St. from Ulen Dr. south to Indianapolis Ave.
N. Outer Dr. southeast from Ulen Dr. to end
Park Dr. from N. Outer Dr. to Outer Dr.
Outer Dr. from Park Dr. to Fordice St.
Fordice St. from Meridian to John Bart Rd.
Meridian from Ulen to Fordice
North East St. from Ulen Dr. to Fordice
Washington St. from Park St. east to John Bart Rd.
Park St. from Fordice to Main
Indianapolis Ave. from East Main St. southeast to City limits
Chicago from Lafayette Ave. east to Clark
Clark St. from Washington to Chicago
Glendale north to Fordice
Grant Blvd. north from Elizaville Rd.
North Lebanon St. from the north city limits to the entrance of
K-mart Shopping Center

(c) the operation of snowmobiles in Memorial Park, Longley Park or on any other street within the corporate limits of the City of Lebanon is prohibited.
