

- (e) All other charges set out above shall be collected at the landfill at the time of deposit of the refuse and remitted daily to the Clerk-Treasurer. The manner of collection and the records to be kept shall be as established by rules adopted by the Board of Public Works and Safety.

Section 2: That Ordinance 79-4 shall be amended by adding to Section 3 a new subsection to be numbered subsection 306 which shall read as follows:

306 The Clerk-Treasurer upon receiving the funds set out in subsection 301.2a above shall record the receipts thereof and disbursements therefrom in a manner to validate the expenditures thereof are used exclusively for the operation of the sanitation department including the landfill.

Section 3: That Section 5 of Ordinance No. 79-4 shall be amended by adding to each subsection between the words "Charges" and the word "for" the words "Solid Waste Disposal Charges" and adding between the words "sewage service" and the word "shall" the words "and solid waste disposal service."

Section 4: That Section 6 of Ordinance No. 79-4 shall be amended by adding in subsection 601 and 602, between the words "Sewage Service" and the word "levied" the words "and solid waste disposal service." The other provisions of subsections 601 and 602 shall remain as originally adopted.

Section 5: That Section 3 of Ordinance No. 79-30 entitled "An Ordinance establishing requirements for registration of Commercial Scavenger Service using the Lebanon sanitary landfill and setting charges therefore" be and the same is, hereby repealed effective January 1, 1981.

Section 6: The provisions of this ordinance shall be in full force and effect from and after January 1, 1981.
