

ORDINANCE NO. 80-27

AN ORDINANCE TO AMEND ORDINANCE NO. 76-15
 ENTITLED "AN ORDINANCE DECLARING AND DEFINING
 THE CORPORATE BOUNDARIES OF THE CITY OF LEBANON,
 INDIANA, AND ANNEXING ALL UNANNEXED TERRITORY
 WITHIN SAID BOUNDARIES," PASSED BY THE COMMON
 COUNCIL ON AUGUST 30, 1976.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION 1: The description of the perimeter boundary of the City of Lebanon, Indiana, attached to Ordinance No. 76-15 as "Exhibit A" of Section 1 of an ordinance entitled "An Ordinance Declaring and Defining the Corporate Boundaries of the City of Lebanon, Indiana, and annexing All Unannexed Territory Within said Boundaries." be amended as follows:

- (a) Strike the word "centerline" from line 22 on page 1 and insert in place thereof the words "South right of way line".
- (b) Strike the word "centerline" from line 23 on page 1 and insert in place thereof the words "south right of way line".
- (c) Strike the word "centerline" from line 4 on page 2 and insert in place thereof the words "southwest right of way line".
- (d) Strike the word "centerline" from the end of line 4 and the start of line 5 on page 2 and insert in place thereof the words "west right of way line".
- (d1) Strike the word "Centerline" from line 6 on page 2 and insert the words "south right of way line" in place thereof.
- (e) Insert the words "south right of way line of State Highway No. 32; thence west to the northeast corner of the west half of the southeast of section 35, township 19 north, range 1 west thence south to a point 1960.10 feet south of the north line of said half quarter section; thence west 325.00 feet to a point 2095.00 feet south of said half quarter section, thence north to the south line of State Highway No. 32; " after the word "west" at the end of line 6 on page 2 and before the word "of" on line no.7 on page 2.
- (f) Strike the words "a distance of 929.26 feet to a point; thence south 0°21'39" west for a distance of 662.37 feet; thence north 89°53'10" east 662.37 feet to the centerline of Sam Ralston Road; thence north with the centerline of Sam Ralston Road to the centerline of Riley Road; thence northeast with the centerline of Riley Road to the east line of Lafayette Avenue; thence northwest with said east" beginning after the word "road" in line no. 13 of page 2 and ending before the word "line" in line 18 of page 2. Insert in place of said words the words "to the southwest corner of the east one-half of the northeast quarter of the southeast quarter of section 26, township 19 north, range 1 west; run thence north 497.8 feet to a point; run thence east to the east line of quarter quarter section; run thence south to the north line of Riley Road; thence northeast with the northline of Riley Road to the west line of Lafayette Avenue; thence northwest with said west line to a point which is directly south of a point in the center of U.S. Highway No. 52 3 chains and 56 links west and north 41 degrees west 656.80 feet; thence deflecting left 90 degrees 37 minutes southwest of the centerline of U.S. Highway No. 52 measure southwesterly 498.64 feet; thence deflecting right 92 degrees 30 minutes measure northwesterly 249.90 feet; thence deflecting right 36 degrees 57 minutes measure northerly 409.88 feet to a point in the west line of U.S. Highway No. 52; thence northwest with said west"

SECTION 2: All territory within said amended boundaries not previously a part of said City are hereby annexed to and shall become a part of the City of Lebanon, Indiana.

SECTION 3: Any other tracts of newly annexed real estate included herein shall be zoned as adjoining real estate within the City, and is now zoned pending zoning classification recommendations by the City Plan Commission.

SECTION 4: The provisions of this ordinance are hereby declared severable. If any of the sections, provisions or phrases be held unconstitutional, the remainder of said ordinance shall remain in full force and effect.

SECTION 5: This ordinance shall be in full force and effect from and after its passage and publication according to law.
