ORDINANCE NO. 81-1

AN ORDINANCE TO AMEND ORDINANCE NO. 77-24, ENTITLED "AN ORDINANCE TO AMEND ARTICLE III, CHAPTER TWO OF THE CITY CODE OF LEBANON, INDIANA, BY INSERTING THEREIN DIVISION THREE THEREOF WHICH SHALL BE ENTITLED, "PERSONNEL POLICIES" PASSED BY THE COMMON COUNCIL ON THE 12TH DAY OF DECEMBER, 1977

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION 1: Subsection A 1 of Section 2-45 entitled Rules and Regulations
Applicable to Employees shall be amended by adding thereto Subsection 2-45(1)

(f) which shall read as follows:

2-45 a. (1) (f) All civilian employees assigned to the police or fire departments shall be excluded from the provisions of subsection 2-45 c and section 2-46 a. Their hours of work and pay for holidays, vacation leave and sick leave shall be governed by the same rules and regulations as govern the members of the police and fire departments.
