ORDINANCE NO. 81-4

AN ORDINANCE REZONING CERTAIN PROPERTY WITHIN
THE CITY OF LEBANON, INDIANA FROM "A" RESIDENTIAL
TO "C" RESIDENTIAL

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:
SECTION 1: The Zoning Ordinance of the City of Lebanon, Indiana and the zone maps which are a part thereof, be amended in the following particulars:
The following described real estate in the City of Lebanon Indiana is hereby zoned to a "C: Residential zoning district classification of the Zoning Ordinance of the City of Lebanon, Indiana, which real estate is described as follows:
A part of the north half of Section 25, Township 19 North, Range 1 West, situated in the City of Lebanon, Center Township, Boone County, Indiana, particularly described as follows:

Begin at a stone at the northwest corner of the northeast quarter of the aforesaid Section 25, and proceed thence South 89°21'53" East (an assumed bearing), along the section line, 290.51 feet; thence South 09°56'53" East, 800.00 feet; thence South 80°03'07" West, 236.10 feet; thence South 09°56'53" East, 1,015.68 feet; thence North 86°21'23" West, along the centerline of the Small-Reynolds Legal Open Drain, 382.11 feet; thence North 64°17'23" West, along the aforesaid centerline, 164.59 feet; thence South 87°06'37" West, along the aforesaid centerline, 225.61 feet; thence North 71°29'23" West, along the aforesaid centerline, 178.05 feet; thence curve left, with a 5,779.58 foot radius curve, along a railroad right-of-way, 210.83 feet (the chord bearing North 09°00'00" West, 210.82 feet; thence North 10°02'42" West, along the aforesaid railroad right of way, 1511.63 feet; thence South 89°39'13" East, along the section line, 848.84 feet to the point of beginning.

SECTION 2: The owner or developer of said above-described real estate prior to commencing placing any improvements thereon shall dedicate to the City an easement for the extension of Garfield Street from its present terminus at the Small-Reynolds Ditch northward to Maple Drive.

SECTION 3: This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor. Passed by the Common Council and approved by me this _____ day of February, 1981.

ORDINANCE NO. 81-5

ADDITIONAL APPROPRIATION ORDINANCE
