

AS THE SAME WAS ADOPTED BY THE COMMON COUNCIL  
ON DECEMBER 8, 1981

WHEREAS, since the adoption of Ordinance No. 80-25, Boone County has withdrawn its contribution of \$20,000.00 per year toward the operation of the City Landfill; and,

WHEREAS, As a result of said withdrawal and the increase in operating cost of the Landfill, the Common Council finds the Landfill will operate at a deficit unless steps are taken to allow the Landfill to operate at the breakeven point.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL of the City of Lebanon, Indiana, that:

SECTION 1: Section 1, subsection 301.2A(a) be amended by striking the first paragraph of said subsection which reads as follows:

This charge shall remain in effect until January 1, 1982, or until the Clerk-Treasurer certifies the January 1, 1981 outstanding balance due Hendricks Excavating has been paid, whichever is earlier. On January 1, 1982, or on certification by the Clerk-Treasurer the charge shall reduce to \$1.00 per month.

SECTION 2: All other provisions of Ordinance No. 80-25 shall remain in full force and effect.

SECTION 3: The provisions of this Ordinance shall be in full force and effect from and after its passage.

ORDINANCE NO. 82-5

AN ORDINANCE CONCERNING THE TRANSFER OF APPROPRIATIONS  
WITHIN THE BUDGET OF LOCAL ROAD AND STREET FUNDS

WHEREAS, certain extraordinary weather emergencies have developed since the adoption of the existing annual budget, so that it is now necessary to reappropriate appropriations within the annual budget;

NOW, THEREFORE, to meet such emergency situation:

SECTION 1: Be it ordained by the Common Council of the City of Lebanon, Boone County, Indiana, that for the expenses of the City of Lebanon the following appropriations shall be transferred:

From 21-422 Capital Outlay to 21-113 Personal Services (O.T.)	\$3000.00
From 21-422 Capital Outlay to 21-230 Supplies (salt, sand)	5000.00
From 21-422 Capital Outlay to 21-231 Rentals	9000.00
	<u>\$17000.00</u>

SECTION 2: This ordinance shall be in full force and effect from and after its passage.

AN ORDINANCE OF THE CITY OF LEBANON, AUTHORIZING THE EXECUTION AND DELIVERY OF A POWER SALES CONTRACT BY AND BETWEEN THE CITY OF LEBANON AND THE INDIANA MUNICIPAL POWER AGENCY, AND OTHER MATTERS CONNECTED THEREWITH

WHEREAS, the City of Lebanon (the "Member") is a municipal corporation created and existing under the laws of the State of Indiana and is a member in good standing of the Indiana Municipal Power Agency (the "Agency")
