ORDINANCE NO. 82-17

AN ORDINANCE ESTABLISHING PARKING LIMITS ON
WEST MAIN STREET AND NORTH WEST STREET

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, that:
Section 1: Parking shall be limited to ten (10) minutes at the following locations:

(a) On the north side of West Main Street from the west curb line of West North Street west to the first alley intersecting with West Main Street

(b) On the west side of North West Street from the north curb line of West Main Street north to the first alley intersecting with North West St.

Section 2: This parking limitation shall be in effect during business hours of the Post Office.

Section 3: Violators of this ordinance shall be subject to the penalty set out in Section 1-10 of the Lebanon City Code.

Section 4: This ordinance shall be in full force and effect from and after its passage.

AN ORDINANCE CONDEMNING CERTAIN REAL ESTATE
