ORDINANCE NO. 82-23

ORDINANCE ESTABLISHING COUNCILMANIC DISTRICTS FOR THE CITY OF LEBANON, INDIANA

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT:

SECTION 1: The city of Lebanon, Indiana, be and it hereby is divided into five councilmanic districts.

SECTION 2: Said districts shall be numbered one through five, shall include certain city precincts with the perimeter descriptions of the boundaries of said districts set out below:

(A) COUNCILMANIC DISTRICT NO. 1

This district shall consist of Boone County Precincts No. One and No. Four, the perimeter description being as follows:

Beginning at the intersection of the centerlines of Meridian Street and Main Street and run north with the centerline of Meridian Street to its intersection with the run west with the centerline of Washington Street centerline of Washington Street/to its intersection with the centerline of North Lebanon Street; run north with the centerline of North Lebanon Street to its intersection with the centerline of West Fordince Street; run east with the centerline of Fordice Street to its intersection with the east boundary line of the City of Lebanon; run south with said boundary line to its intersection with the centerline of East Green Street extended east; run west with the centerline of East Green Street to its intersection with the centerline of South East Street; run north with the centerline of South East Street to its intersection with the centerline of East Main Street; run west with the center-
