

(B) COUNCILMANIC DISTRICT NO. 2

This district shall consist of Boone County Precincts No. Three and No. Eight, the perimeter description being as follows:

Beginning at the intersection of Main Street and Meridian Street and run north with the centerline of Meridian Street to its intersection with the centerline of Washington Street; run west with the centerline of Washington Street to its intersection with the centerline of North Blair Street; run south with the centerline of North Blair Street to its intersection with the centerline of West Main Street, run west with the centerline of West Main Street extended to its intersection with the centerline of Sam Ralston Road, run south with the centerline of Sam Ralston Road to its intersection with the centerline of West South Street, the same being State Highway No. 32; run west with the centerline of West South Street - State Highway No. 32 - to its intersection with the centerline of I-65; the same being a point in the west boundary line of the City of Lebanon; run southeast and north with the City boundary line to its intersection with the centerline of East Green Street extended east; run west with the centerline of East Green Street to its intersection with the centerline of South East Street; run north with the centerline of South East Street to its intersection with the centerline of East Main Street; run west with the centerline of East Main Street to the point of beginning.

In the event any additional area adjacent to either of the above precincts is annexed to and becomes part of such precincts, then such area shall become part of this district.

(C) COUNCILMANIC DISTRICT NO. 3

This district shall consist of Boone County Precincts No. Two and No. Ten, the perimeter description being as follows:

Beginning at the intersection of North Lebanon Street and Washington Street and run west with the centerline of West Washington Street to its intersection with the centerline of North Blair Street; run south with the centerline of North Blair Street to its intersection with the centerline of West Main Street; run west with the centerline of West Main Street extended to its intersection with the centerline of Sam Ralston Road; run south with the centerline of Sam Ralston Road to its intersection with the centerline of West South Street, being also State Highway No. 32; run west with the centerline of West South Street - State Highway No. 32 to the west boundary line of the city of Lebanon; run north and east with the boundary of the city of Lebanon to its intersection with the centerline of Lafayette Avenue; run southeast with the centerline of Lafayette Avenue to its intersection with the centerline of Royal Street; run east with the centerline of Royal Street to its intersection with the centerline of Hoy Avenue; run north with the centerline of Hoy Avenue to its intersection with the centerline of West Camp Street; run east with the centerline of West Camp Street to its intersection with the centerline of Ulen Drive; run northeast with the centerline of Ulen Drive to its intersection with the centerline of North East Street; run south with the centerline of North East Street to its intersection with the centerline of East Fordice Street; run west with the centerline of East Fordice Street to its intersection with the centerline of North Lebanon Street; run south with the centerline of North Lebanon Street to the point of beginning.

In the event any additional area adjacent to either of the above precincts is annexed to and becomes part of such precincts, then such area shall become part of this district.

(D) COUNCILMANIC DISTRICT NO. 4

This district shall consist of Boone County Precinct No. Seven, the perimeter description being as follows:

Beginning at the intersection of West Camp Street and North Lebanon Street; run north with the centerline of North Lebanon Street to its intersection with the north boundary line on the west side of North Lebanon Street; run west and south with the north and west boundary line of the City of Lebanon to its intersection with the centerline of Lafayette Avenue; run southeast with the centerline of Lafayette Avenue to its intersection with the centerline of Royal Street; run east with the centerline of Royal Street to its intersection with the centerline of Hoy Avenue; run north with the centerline of Hoy Avenue to its intersection with the centerline of West Camp Street; run east with the centerline of Camp Street to the point of beginning.

In the event any additional area adjacent to the above precinct is annexed to and becomes part of such precinct, then such area shall become part of this district.

(E) COUNCILMANIC DISTRICT NO. 5

This district shall consist of Boone County Precinct No. Nine, the perimeter description being as follows:

Beginning at the intersection of the centerline of North Lebanon Street and the centerline of West Camp Street and run east with said centerline to its intersection with the centerline of Ulen Drive; run Northeast with said centerline to its intersection with the centerline of North East Street; run south with said centerline to its intersection with the centerline of Fordice Street; run east and north with said centerline to the east boundary line of the City of Lebanon; run north with the east boundary line of the City of Lebanon to its intersection with the centerline of North East Street; run south with the centerline of North East Street to its intersection with the centerline of Fordice Street; run west with the centerline of Fordice Street to its intersection with the centerline of West Camp Street; run south with the centerline of West Camp Street to the point of beginning.
