ORDINANCE NO. 82-25

AN ORDINANCE CONCERNING AMENDMENT OF THE POWER SALES CONTRACT BETWEEN THE CITY OF LEBANON AND THE INDIANA MUNICIPAL POWER AGENCY AND OTHER MATTERS CONNECTED THEREWITH

WHEREAS, the Indiana Municipal Power Agency ("IMPA") has advised the City through the City's representative on the Board of Commissioners of IMPA that the Power Sales Contract between the City and IMPA should be amended since certain delays in obtaining the necessary arrangements and regulatory approval may make it impossible for that agreement to be practically effective by January 1, 1983; and

WHEREAS, the City finds it necessary and desirable to amend that document to provide for its effectuation by July 1, 1983 and to authorize its appropriate officials to take any actions necessary to accomplish that amendment;

NOW, THEREFORE, BE IT ORDAINED:

Section 1. Section 3(a) of the Power Sales Contract is hereby amended by deleting the phrase "... commencing January 1, 1983 or such earlier date as shall be determined by the Agency upon thirty days notice to the Member ..." and by inserting in its place the phrase "...commencing on a date to be specified in a manner determined by the Agency, but in any event commencing no later than July 1, 1983,..."

Section 2. The Mayor and Clerk-Treasurer are hereby authorized and directed to take any action necessary to effectuate the amendment provided for herein.

Section 3. This ordinance shall be in full force and effect as of its passage.
