ORDINANCE NO. 82-28

AN ORDINANCE TO REESTABLISH THE LEBANON UTILITY
SERVICE BOARD

WHEREAS, the Lebanon Utility Service Board was established by Ordinance prior to the present requirement of IC 8-1.5 for a voter referendum, and

WHEREAS, the Lebanon Utility Service Board has been in continuous existence since being formed by Ordinance as passed by the Common Council in 1942, amended in 1963 and 1977 and

WHEREAS, Public Law 74 amending IC 8-1 passed by the 1982 Indiana Legislature repeals IC 8-1-2-100 under which the Lebanon Utility Board is operated, and

WHEREAS, no continuation clause for those Utility Service Boards already operating was included in PL 74, which is specifically IC 8-1.5, and

WHEREAS, without any Common Council action prior to January 1, 1983, it would require a referendum of the voters of Lebanon to reaffirm and reestablish the existence of the Lebanon Utility Service Board, and

WHEREAS, there would be unnecessary expenses incurred to take this action, as well as leaving a period of time of indecision from January 1, 1983, until a referendum is conducted and subsequent Common Council action, taken and

WHEREAS legislation is now pending in the Indiana General Assembly to correct the omission in IC 8-1.5;

NOW THEREFORE

BE IT ORDAINED BY THE COMMON COUNCIL THAT:

Section 1. The Lebanon Utility Service Board shall continue, effective January 1, 1983, pending corrective legislative action; that said Board shall have the same members with the same terms as are now in effect.

Section 2. The powers of said Board shall be as are set out in IC 8-1.5-3-4 and any subsequent amendments passed by the Indiana General Assembly.

Section 3. This Ordinance shall continue in full force and effect pending the adoption of corrective legislation by the Indiana General Assembly.
