Section 2: Chapter 7 of the City Code of Lebanon, Indiana be amended as follows:

- (a) Section 7-39 be amended by inserting in the second line thereof between the words "wiring" and "in", the words "General Contractor".
- (b) Section 7-40 be amended by adding a second paragraph to read as follows:
"In the event an applicant fails an examination he must wait **thirty days** before again making a new application to take the examination. Such new application shall be accompanied by a new application fee".
- (c) Section 7-42 shall be amended by striking therefrom the sum "twenty-five (\$25.00) dollars" and inserting in place thereof the sum "thirty-five (\$35.00) dollars". Said section shall be further amended by striking therefrom the sum "five dollars (\$5.00)" and inserting in place thereof the sum "twenty-five (\$25.00) dollars".
- (d) Section 7-45 and 7-60 shall be amended by striking therefrom the sum "ten dollars (\$10.00)" wherever it appears and inserting in place thereof the sum, "twenty dollars (\$20.00)".
- (e) Section 7-57 be amended by striking therefrom the sum "twenty-five dollars (\$25.00)" and inserting in place thereof the sum "thirty-five dollars (\$35.00)".

Section 3: This ordinance shall be in full force and effect from and after its passage.

ORDINANCE NO. 83-15

AN ORDINANCE GRANTING A NEW FRANCHISE TO TELECOMMUNICATIONS, INC., ITS SUCCESSORS AND ASSIGNS TO CONTINUE ITS OPERATION AND MAINTENANCE OF ITS PRESENT CABLE TELEVISION SYSTEM IN THE CITY OF LEBANON, INDIANA AND TO CONSTRUCT EXTENSION AS NEEDED, AND ALSO SETTING FORTH CONDITIONS ACCOMPANYING THE GRANT OF FRANCHISE FOR CITY REGULATION AND USE OF THE CABLE TELEVISION SYSTEM

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, INDIANA, THAT a new Cable Television system franchise be granted to Tele-Communications, Inc. as hereinafter set forth.

Section 1: DEFINITIONS. For the purpose of this ordinance the following terms, phrases, words, abbreviations and their derivations shall have the meaning herein given. When not inconsistent with the context, words used in the present tense include the future tense, words in the plural number include the singular number, and words in the singular number include the plural number.
