WHEREAS, the council having considered the Petition to Vacate Alley and now being duly advised in the premises, does hereby find that the Petitioner's Petition should be granted.

IT IS THEREFORE, ORDERED, ADJUDGED AND DECREED that a certain alley located on real estate legally described upon the attached survey, which is marked Exhibit "A" and made a part of this Vacation Ordinance by reference, should be and the same is hereby vacated.

IT IS FURTHERMORE ORDERED, ADJUDGED AND DECREED that a copy of this Vacation Ordinance be recorded in the Recorder's Office, of Boone County, Indiana, all in accordance with the requirements of IC36-7-3-12, and the Clerk-Treasurer is hereby ordered to make the recording of this Vacation Ordinance at the expense of Petitioners Ronald E. Smith and James P. McGinley.

ORDINANCE NO. 83-24

AN ORDINANCE TO AMEND CHAPTER 25 OF THE
CITY CODE OF LEBANON, INDIANA BY ADDING
A NEW SECTION TO BE NUMBERED SECTION 25-98

BE IT ORDAINED BY THE Common Council of the City of Lebanon that:

Section 1: Ordinance No. 64 passed by the Common Council on November 24, 1958 established a sewer equalization fee for tapping into the sanitary sewers constructed as part of the modernization of the city sewer system in 1958.

Section 2: Said sewer equalization fee shall be incorporated into the City Code of Lebanon, Indiana as Section 25-98 which shall read as follows:

Section 25-58 Sewer Equalization Fee

Section 1: There is hereby established an equalization fee for tapping into sanitary sewer system of the City of Lebanon, Indiana and such fee shall be as follows:

Residential Lot fees shall be \$200.00; provided, however that whenever anyone who is not being served by sanitary sewer at the time of the passage of this ordinance shall be permitted to tap said sewer for a fee of \$35.00; provided, further, that in the event said tap is not made within one (1) year after this ordinance becomes effective, as above set out, then said fee shall revert to \$200.00.
