

## ORDINANCE NO. 84-20

AN ORDINANCE AUTHORIZING THE DISPOSAL  
OF SURPLUS PERSONAL PROPERTY AND  
APPOINTMENT OF DISPOSING AGENT

BE IT ORDAINED by the Common Council of the City of Lebanon, Indiana, that:

Section 1: The Street and Sanitation Department of the City of Lebanon has on hand certain personal property which belongs to the City and is considered unfit and no longer proper for the purpose for which it was intended and the same should be disposed of pursuant to the laws of the State of Indiana in that it has a total estimated value of more than One Thousand Dollars (\$1,000.00) as shown by appropriate estimates of its value presented to the Common Council. Said personal property consists of the following, to-wit:

1. 1974 Ford Model 900 garbage truck with each 18-yard packer capacity, serial number N90KVU87260, approximate valuation, \$4,700.00.
2. 1977 International Loadstar Model 1800, sixteen-yard packer garbage truck, serial number D0532GHA17254, approximate valuation, \$2,000.00
3. Single-axle trailer mobile home, silver and red in color, approximate dimension 7x15 feet, in fair shape, approximate valuation, \$200.00.

Section 2: The aforementioned personal property is qualified to be disposed of pursuant to I.C. 36-1-11-6(a)(2) and I.C. 36-1-11-6(b)(2).

Section 3: The head of the Street and Sanitation Department is hereby appointed as Disposing Agent and directed to dispose of said personal property under the terms of I.C. 36-1-11-6(b)(2). Since the estimated value of the personal property is more than the statutory amount of One Thousand Dollars (\$1,000.00), and the same consists of more than One (1) item, the Disposing Agent shall sell the personal property at a public auction, which is to be conducted by an auctioneer licensed under I.C. 25-6.1, after advertising the personal property for sale in accordance with I.C. 5-3-1, which in this event requires that notice shall be published two (2) times, at least one week apart, with the second publication made at least three (3) days before the public sale.

Section 4: Since the third item referenced above, the single-axle trailer, is of a value less than Five Hundred Dollars (\$500.00), the Disposing Agent may elect to proceed under the provisions of I.C. 36-1-11-6(c) and sell the same at public or private sale or transfer the property without advertising rather than include it with the sale of the two (2) trash disposal vehicles if he deems the same action to be appropriate, or at his option, if the personal property is deemed worthless, the same may be demolished or junked by the Disposing Agent appointed herein.

Section 5: The Disposing Agent is hereby directed to make a report of his action under this Ordinance upon completion of the sale of disposal of said property.

Section 6: This Ordinance shall become effective from and after its passage.
